Claimants filed a land dispute claim on June 20, 2018; respondents moved to dismiss the claim; plaintiffs seek to file an amended complaint; respondents object. The parties appeared before the Court and made oral argument. The Court required the parties to file position papers/memoranda with respect to their arguments and Tribal Council Resolution 99-21. In filing such documents, claimants have filed a statement of facts and their proposed amended complaint with several exhibits attached; respondents have filed a memorandum of law and an amended answer.

The Court has reviewed the filed documents. It finds that there are several documents that would be necessary for, and/or helpful to, the Court in determining the issues before it. Many of those items are in the possession of the Tribal Clerk's Office and may not be readily available to the parties. Others are necessary to be produced by the parties.

THEREFORE, upon the foregoing, it is:

ORDERED that claimants shall provide to the Court on or before January 24, 2019:

1. the death certificate of Marita Skidders:

- 2. the purported Power of Attorney granted to Honey Skidders by Marita Skidders;
- 3. the purported "transfer of land" dated April 15, 1979, from the estates of Peter Hopps and Margarette Hopps to Marita Skidders;

and it is further

ORDERED that respondents shall provide to the Court on or before January 24, 2019:

- 1. the death certificate of Lawrence Skidders:
- 2. the minutes of the purported 1993 Ten-day Feast held upon the death of Lawrence Skidders;

and it is further

ORDERED that the Tribal Clerk shall provide to the Court on or before January 24, 2019:

- 1. copies of minutes of all Tribal Council meetings between January 1, 1993, and 2004 wherein Council considered the topic which is the subject of this proceeding, i.e., use and occupancy of the real property known as the "Peter Hopps Estate" also designated
- 2. copies of any and all deeds issued by the Tribal Clerk between 1978 and 2004 which transfer use and occupancy to the real property known as the "Peter Hopps Estate" also designated
