## FEMA Emergency Management Framework for Tribal Governments course (L0580)

February 20 - 23, 2024 from 8:00 a.m. - 5:00 p.m.

**Course Purpose:** To help ensure the protection of Tribal members and Tribal communities in times of disaster occurrences through gaining an understanding of your role in emergency management, critical plans, and comprehensive emergency management systems.

This 4-day course provides Tribal emergency management/response personnel, tribal government employees, and Tribal leaders with a basic understanding of emergency management principles and their role in leading and directing their tribes in developing and implementing comprehensive emergency management systems. Specific topics include identification and analysis of hazards, developing an Emergency Operations Plan (EOP) and other planning, assuring readiness through training and exercises, forming partnerships in the public and private sectors, and upgrading and sustaining emergency management capabilities.

**NOTE:** ICS 100 and 200 are strongly recommended prior to taking this course

**Intended Audience:** Tribal leaders, Tribal emergency managers, Tribal emergency response personnel, Tribal government agency/department heads, and Tribal government employees.

Students completing the course receive an EMI Certificate of Completion for 2.4 CEUs in an e-mail after the course is completed.

The training and materials are free. Lunch and refreshments are included.

Travel expenses are the responsibility of the student's organization.

You'll need a FEMA Student Identification Number (SID) on your application. You can obtain a SID by going to <https://cdp.dhs.gov/femasid/> and please bring your SID number to class.
