

## Saint Regis Mohawk Tribe

**Tribal Council Resolution** 2008- 8 Amendment to TCR 99-074 St. Regis Mohawk Tribal Uniform Fire Prevention and Building Code Act

WHEREAS, the St. Regis Mohawk Tribal Council is the duly recognized governing body of the St. Regis Mohawk Tribe and is responsible for the health, safety, education and welfare of all members of the tribe; and

WHEREAS, the St. Regis Mohawk Tribal Council has adopted the New York State Uniform Fire Prevention and Building Code as Tribal Law; and

WHEREAS, this law was ratified by the St. Regis Mohawk Tribal Council through TCR 2001-24; and

WHEREAS, there is a need to clarify the applicability of the St. Regis Mohawk Tribal Uniform Fire Prevention and Building Code Act; and

WHEREAS, the New York State Uniform Fire Prevention and Building Code is amended on a yearly basis; now

THEREFORE BE IT RESOLVED THAT, the St. Regis Mohawk Tribal Uniform Fire Prevention and Building Code shall be automatically referenced as the most recent version of the New York State Uniform Fire Prevention and Building Code Act; and

BE IT FURTHER RESOLVED that the St. Regis Mohawk Tribal Uniform Fire Prevention and Building Code Act shall govern all construction performed within the territorial jurisdiction of the St. Regis Mohawk Tribe from this date forward; and any existing buildings located within the territorial jurisdiction of the St. Regis Mohawk Tribe prior to this date shall be deemed to be in compliance with the provisions of this act.

BE IT FINALLY RESOLVED that the following individuals have successfully completed the 2007 NY Uniform Fire Prevention and Building Code Enforcement Training Program and are hereby appointed to serve as the St. Regis Mohawk Tribe's Code Enforcement Officers for purposes of permitting, inspection and enforcement of the St. Regis Mohawk Tribal Uniform Fire Prevention and Building Code Act, with the appropriate increase to their salaries to reflect this additional responsibility: Mark Martin and Elliot Lazore.
